PROCEDURES FOR FILING A GARNISHMENT

Filing Fee is \$108.00 per garnishment. Check made payable to: Oconee County Magistrate Court.

The Defendant must work in Oconee County for the garnishment to be filed with this court.

The jurisdictional limit for filing a garnishment in the Magistrate's Court is \$15000.00. Any claims exceeding this amount must be filed with the Clerk of Superior Court.

The Plaintiff is the party filing the garnishment, the Defendant is the party that the original claim was against, and the Garnishee is the name of the business the defendant works at

The Garnishment papers must be completely filled out and notarized including the complete street address of Garnishee (no P.O. Boxes acceptable) and the mailing address for the Plaintiff. Please include a copy of the Judgement you are basing the Garnishment on.

Deliver or mail the original of the Garnishment forms along with the filing fee. ANY FORMS RECEIVED THAT ARE NOT FILLED OUT CORRECTLY WILL BE RETURNED TO YOU. THIS INCLUDES THE FILING FEE. Please include a copy of the Judgment you are basing your garnishment filing on. Our Judge will NOT approve Garnishment cases without the Judgment.

Once your garnishment has been filed with the Court, the forms will be processed and forwarded to the Sheriff's Department for service. Once the forms are processed, no refunds will be made. Garnishments must be served personally on the garnishee; they cannot be tacked and mailed.

You MUST give the defendant notice that you have filed a garnishment against them. This must be done via certified mail to the defendant's last known address. Upon receipt of either the green card or the returned undelivered envelope, you must provide the court with either the original or a copy of the green card or envelope. WE WILL NOT DISBURSE ANY FUNDS OUT TO THE PLAINTIFF UNTIL WE RECEIVE PROOF OF NOTIFICATION ON THE DEFENDANT BY CERTIFIED MAIL.

Once service is completed, the Court will mail you a copy of the Sheriff's Entry of Service form. The garnishee has 45 days to answer the garnishment to the court in writing. This could either be with or without money. Any money we receive must stay in the magistrate registry account for a minimum of fifteen (15) days before we can disburse the money out to you. We must have a written request for the money to be disbursed to you every time that we receive answers with money. We do not automatically send out the money, and one request does not suffice for all monies received after that. We do require a separate request each month. However if you wish to wait until all monies have been received by the court to request disbursement you may do that as well.

**NOTICE TO DEFENDANT OF RIGHT AGAINST GARNISHMENT  
OF MONEY, INCLUDING WAGES, AND OTHER PROPERTY**

You received this notice because money, including wages, and other property belonging to you have been garnished to pay a court judgment against you. HOWEVER, YOU MAY BE ABLE TO KEEP YOUR MONEY, INCLUDING WAGES, OR OTHER PROPERTY. READ THIS NOTICE CAREFULLY.

State and federal law protects some money, including wages, from garnishment even if it is in a bank. Some common exemptions are benefits from social security, supplemental security income, unemployment, workers' compensation, the Veterans' Administration, state pension, retirement funds, and disability income. This list of exemptions does not include all possible exemptions. A more detailed list of exemptions is available at the Clerk of Court's office located at OCONEE CO. MAGISTRATE (Name of Court), 23 N Main St (Address), Watkinsville (City), Georgia 30677 (ZIP Code), and on the website for the Attorney General ([www.law.ga.gov](http://www.law.ga.gov)).

Garnishment of your earnings from your employment is limited to the lesser of 25 percent of your disposable earnings for a week or the amount by which your disposable earnings for a week exceed \$217.50. More than 25 percent of your disposable earnings may be taken from your earnings for the payment of child support or alimony or if a Chapter 13 bankruptcy allows a higher amount.

**TO PROTECT YOUR MONEY, INCLUDING WAGES, AND OTHER PROPERTY  
FROM BEING GARNISHED, YOU MUST:**

1. Complete the Defendant's Claim Form as set forth below; and
2. File this completed claim form with the Clerk of Court's office located at OCONEE CO. MAGISTRATE

**FILE YOUR COMPLETED CLAIM FORM AS SOON AS POSSIBLE.** You may lose your right to claim an exemption if you do not file your claim form within 20 days after the Garnishee's Answer is filed or if you do not mail or deliver a copy of your completed claim form to the Plaintiff and the Garnishee at the addresses listed on this notice.

The Court will schedule a hearing within ten days from when it receives your claim form. The Court will mail you the time and date of the hearing at the address that you provide on your claim form. You may go to the hearing with or without an attorney. You will need to give the Court documents or other proof that your money is exempt.

The Clerk of Court cannot give you legal advice. **IF YOU NEED LEGAL ASSISTANCE, YOU SHOULD SEE AN ATTORNEY.** If you cannot afford a private attorney, legal services may be available.
